Article I/ Objective

Article II/Duration

II.1 The present agreement shall enter into force on the date when the last party signs.

ARTICLE III/ Role and tasks of the initiating organization

The *initiating organization* will be responsible for the implementation and development of project activities in each phase and will support and assess the *partner entity* in performing the activities. It will coordinate the project at national level. Its main task will be the facilitation of the access of the partner entity to the online platform developed by the project coordinator for learning, consultation and research, in order to strengthen the cooperation between students, academia and business environment and to transpose the added value of the knowledge into practice.

ARTICLE IV/ Role and tasks of the partner entity

The partner entity will participate in the project to support the development of learning through cooperation between academics and practitioners. The main task will be to use the online platform developed by the project coordinator for learning, consultation and research, in order to strengthen the cooperation between students, academics and the business environment, for transposing the value added of knowledge into practice.

The online platform is meant to be an interface between classroom and practice, respectively a virtual meeting place for students, teachers, and employers.

Companies and professional bodies will be invited to upload announcements regarding internships offered and demanded, but also to describe real-world accounting and audit topics, that can be used in the classroom as case studies.

ARTICLE V/Financing

The participation of the partner entity and the performance of the tasks specified in Article IV will be done on voluntary basis and there will be no remuneration for this participation. The initiating organization will provide the necessary human resources for a correct management and implementation and will finance the necessary activities for its success.

ARTICLE VI/Termination of the agreement

VI.1. Termination of the agreement by the initiating organization

The initiating organization could terminate this agreement if it considers that the partner entity is not implementing and carrying out the tasks and activities foreseen and collected in this agreement. In this case, the initiating organization will inform the partner.

VI.2. Termination of the agreement by the partner entity

The partner entity can decide to terminate this agreement without any penalty. Such termination shall be effected by giving the project organization at least thirty (30) days advance written notice of its intention to terminate.

ARTICLE VII/ Publicity

Unless the initiating organisation requests or decides otherwise, any communication or publication related to the activities collected in this agreement under the STAMP-ONLINE project framework by the partner entity or the initiating organization shall indicate that the action has received funding from the European Union and that the partner entity and the initiating organisation collaborate within the project.

In addition, any communication or publication shall indicate that the sole responsability lies with the author and that the Agency and the Commision are not responsible for the use of any information contained in that document.
